2 Bences Close. Erection of a single storey rear extension to form additional living accommodation. P22/01827/HH

2 Chippenham Road. Works to crown reduce 2 Lawson cypress by 8m in height and 2m in width, to crown reduce 1 Rowan by 3m in height and 1m in width, to crown reduce 1 Apple by 3m in height and 2m in width, and works to pollard 1 Pussy Willow to main stem removing 10m of growth. P22/01705/TCA
